## The Science of Addiction Medicine:

**Sarah Landres** is an Associate Attorney with Primmer, Piper, Eggleston, and Cramer, PC. Her practice focuses on domestic relations and criminal defense. John earned his MBA from Southern NH University and is credentialed as a Certified Recovery Support Worker (CRSW). SOS Recovery Community Organization has grown from a \$5000 all-volunteer effort in September 2016 into a robust program with 20 full-time employees and a budget of over \$1 million. SOS has three recovery community centers, numerous initiatives including a statewide criminal justice program serving those in rural areas with digital recovery supports.

## **Trauma as a Gateway to Substance Abuse:**

**Kerry Nolte** is an assistant professor of nursing at the University of New Hampshire. Kerry's work focuses on reducing the harms associated with drugs. Specifically, her research is concerned with injection-related harms including overdose and infection prevention.
